3. Description of Program	Four-week program in international business law and European law, including EU law and European institutions. The program involves out of class work, class work, and site visits to related institutions.

10. Description of each course (including credits)	International Business Law (LAW 910-001; 3 credits) which will include visits to important international institutions and cover the basic tenants of business law in an international and European context. It will provide students with solid instruction on new legal concepts, jurisprudence, and institutions reflecting the globalization of commerce. Particular attention will be given to the Organization for Economic Cooperation & Development (OECD), the European Bank for Reconstruction and Development, and

	<p>the use of arbitration to resolve international business disputes.</p> <p>European Union Law and European Institutions (LAW 911-001; 3 credits): This course provides an introduction to the fundamental treaties governing the European Union and the major institutions of the European Union. Students will examine such issues as: basic freedoms under the treaty, including free movement of persons, goods, services, and capital; competition law in the EU. In addition, this course will introduce the European regional systems that govern the protection of human rights, including the Council of Europe, and the European Court of Human Rights.</p>
11. Schedule of classes (including days and times for each)	Classes will meet in the mornings, Monday through Friday. Site visits will be scheduled in the afternoons. This schedule may be adjusted to accommodate travel and site visits.
12. Student performance requirements	Class and site visit attendance are required. There will be regular out of class assignments and final examinations.
13. Grading method	Normal grading, A-F scale.
14. Enrollment limitations on any course offered	None.
15. Criteria for enrollment (including prerequisites)	Students must have completed at least one year of full- or part-time legal education at an ABA-approved or described law school. Students must also be in good standing at their home institutions, as verified by the Office of the Registrar, and must complete the program application before the program is full.
16. Statement that student's home school determines acceptance of credit received (for course, externship or clinical offering)	Applicants who intend to transfer credits should inquire about their law school's policy on that issue: acceptance of any credit or grade for any course taken in the program, including externships or any clinical offerings, is subject to determination by the student's home school. Applicants should be aware that participation in the program is unlikely to accelerate graduation for a full-time student.
